Claiming money and medical care when you have suffered an accident

Have you suffered an accident?

If you have had an accident in the last 3 years we can help you claim compensation. If another party is to blame, you can receive money for your injuries or illness suffered.

We can get you physiotherapy, osteopathy and counselling to help you recover. We can get you money for your personal loss, which includes loss of earnings, property damage, repair of your car, tow away charges and insurance policy excess.

We can advise on all accidents, including:

- traffic accident - even if the other driver has no insurance
- tripping or slipping in the street or business premises
- accident at work
- exposure to health risks at work
- fatal accidents - compensation for family dependants
- criminal attacks

What will it cost?

To begin with, we can discuss your case with you, at no cost. This will usually be by phone. This may take about half an hour where we can advise you as to the likely success of your claim.

There are three ways to cover the cost:

1. A 'no win, no fee' arrangement (also known as a Conditional Fee Agreement). If you do not win you do not pay.
2. By activating of your own insurance legal expenses with your insurance company supporting your claim.

3. A private client — and when you are successful, the other side settles your costs when the case ends.

Provided your claim is worth more than £1,000, the other party have to pay your legal costs at the end of the case.

We are often able to obtain an interim payment, which is advance money from the insurance company while your case continues, making sure your financial hardship is reduced.

How does it work?

- If we believe you have a case we will proceed and promptly get the other side to admit liability.
- We will arrange a medical examination and can then value your injury claim precisely, including payment for any other treatment you need.
- We prepare details of all your personal losses

suffered, to include earnings, policy excess, travel and care.

Warning -

beware of your opponent's insurers

Quite often your opponent's insurance company will get in touch and try to settle your case for less than you are due. Their approach may relate to you having a hire car or suggesting you use their medical expert for examination. At these times you need the advice of an independent, qualified lawyer, which we will provide, to maximise your money.

Criminal attack

If you are attacked and injured, even if the police cannot trace your attacker, you can get an award from the Criminal Injuries Compensation Authority (CICA). We have a separate leaflet explaining this.

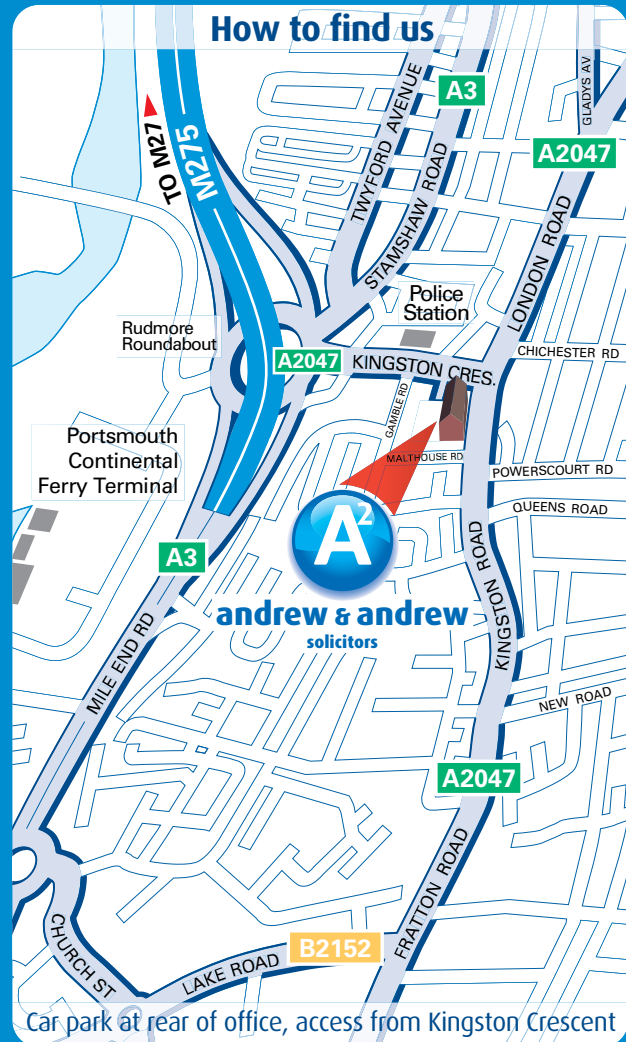
